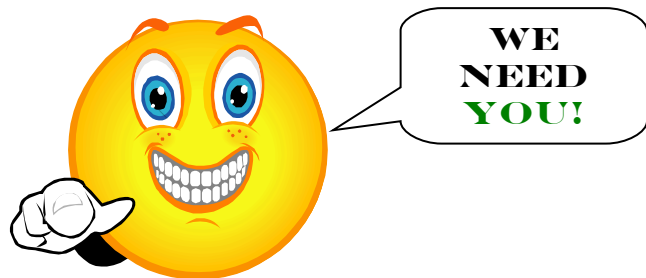
HAPPY NEW YEAR!!!
